Scope of Services

This year Inner Circle FFA remained providing out of home care through foster care services to clients. Children continue to be placed in agency approved Resource Homes that have gone through **extensive training** and **thorough background checks**.

Once a child is placed in the home, our social workers continue to complete **required visits** once a week and **maintain constant contact** with the child in person or through telephone. Services such as individual counseling and family therapy (if applicable) remain available through referrals to **all** children and resource parents. In addition to the services, **treatment objectives** continue to be developed by our social workers, the placing agency, resource parents, and birth parents when it is appropriate.
