Scope Of Services

In 2018, Inner Circle Foster Family Agency has:

- Continued to provide services from a person- centered perspective and approach through:
 - Ongoing and supportive out of home care services to clients in placement
 - Thorough assessments of potential Resource Homes through extensive background checks, training, home assessments, etc.
 - And much more!

Inner Circle's Foster Care Social Workers have diligently worked towards assisting clients through:

- Developing positive relationship with clients through weekly visits for ongoing support and checking of their well-being
- Remaining available 24/7 for emergencies and support
- Facilitating referrals of services for clients
- Maintain ongoing communication and collaboration with the client's support team
- Advocating for client's needs

Children's Advocacy Center

Inner Circle Children's Advocacy Center is a team consisted of **multidisciplinary professionals** who investigate cases of reported child abuse and cases which a child may have been a witness to a crime. The Children's Advocacy Center works with Law Enforcement, prosecutors, social workers, advocates, medical and mental health professionals to provide **socialized services** for abused children and their families such as **forensic interviews, family advocacy and mental health services**

Forensic Interviews

Forensic Interviews are conducted to gather detailed information about possible event(s) that a child may have witnessed, to assess if a child has been abused, develop a safety plan for the child, minimize trauma and lay the groundwork for the abuser's prosecution.

Family Advocacy

Inner Circle Children's Advocacy Center will provide a family advocate to all families that visit the office. The family advocate will offer support and walk the families through the entire process as well as provide resources that are beneficial to the child and family.

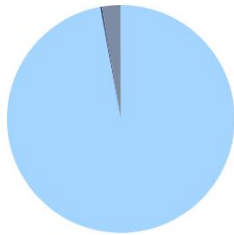
Mental Health Services

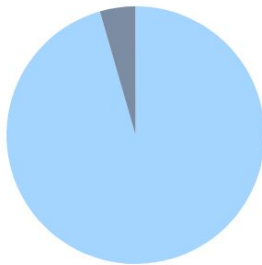
Revenue
