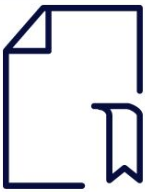

Scope of Services

In 2019, Inner Circle FFA has continued:

- Providing in home individualized child support for client
- Providing weekly visits by Foster Care Social Workers for each client in placement
- Providing constant contact with client through telephone or in person
- Being available 24/7 for emergencies and support
- Working in collaboration with client's service team to develop treatment goals specific to each client
- Providing referrals for services such as tutoring, individual counseling and family therapy to all Resource Parents and children in care when applicable and deemed appropriate
